SECTION 8: FINGERPRINTING (LIVE SCAN)

SECTION 13: ONGOING COMPLIANCE (POST-LICENSE)
<ul> <li>□ Maintain active bond and insurance (annual renewal)</li> <li>□ File Reports of Sale (ROS) within 5 days of sale</li> <li>□ Submit title and registration within 30 days</li> <li>□ Remit sales tax to CDTFA on schedule</li> <li>□ Keep records for 4 years minimum</li> <li>□ Renew dealer license annually (via OL Portal)</li> <li>□ Take 4-hour renewal education every 2 years</li> <li>□ Display license number on all ads</li> <li>□ Monitor and renew dealer plates annually</li> <li>□ Keep business hours posted and accurate</li> <li>□ Maintain professional and compliant advertising</li> </ul>
